Providing training to all employees to raise awareness of environmental issues and encourage sustainable practices.

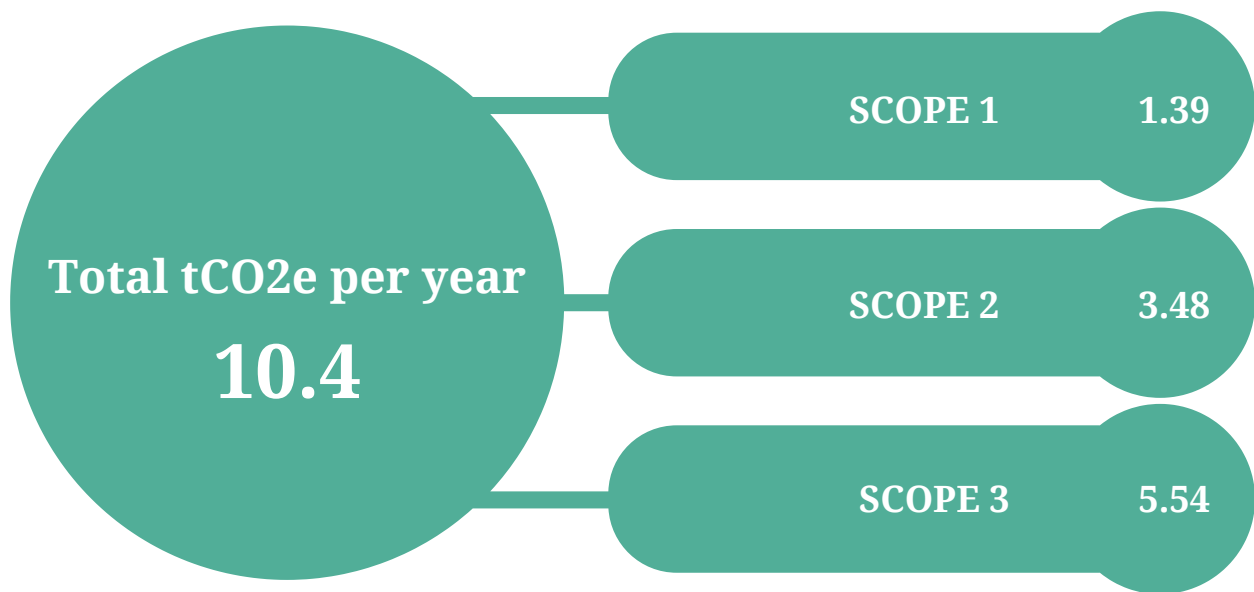

Scope 1 - These are our direct emissions – the ones from sources owned or controlled by our business. Scope 1 emissions are from these data sections: Fuels and Electricity, Business Vehicles, Materials, and Refrigerant Gas data sections.

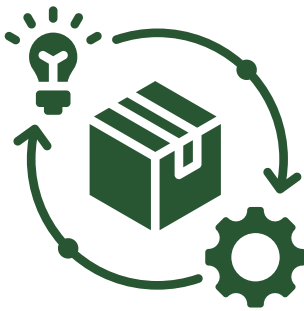
Scope 2 - These emissions come from the production of the electricity our business buys and uses.

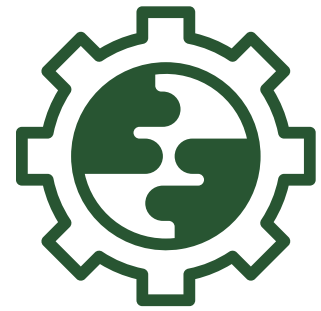
